## 1. COURSE OBJECTIVE

The aim of the course is to provide an understanding of the principles and practices of environmental management system (EMS) auditing and to impart practical training on environmental auditing skills.

## 2. WHO SHOULD ATTEND?

The course is suitable for those:

- Who require a detailed knowledge of EMS auditing process.
- Whose jobs involve assessment of EMS of suppliers and potential suppliers.
- Who are responsible for managing the internal EMS audit function within their organisation.
- Who are involved in preparing their organisation for assessment by customers or certification body.
- Who wish to become registered as EMS Auditor or Lead Auditor with International Register of Certificated Auditors (IRCA, IQA - UK).

## 3. PREREQUISITE

Prior to commencement of the course, participants are expected to have an understanding of the content & implementation of ISO 14001 international standard on EMS.

## 4. COURSE CONTENTS

- Review and update on ISO 14001:2004 and relationship between different EMS standards.
- Techniques for the identification of environmental aspects ranging from risk assessment methodologies, life cycle analysis, emission analysis, identification of significant releases.
- Assess the degree of control of environmental impacts within an organisation and how to evaluate the effectiveness of these measures.

- Environmental legislations and international treaties, conventions and charters.
- Assessing the programmes and delivery of internal EMS auditing within an organisation and investigating the management review of the system.
- The EMS Auditing Process including exercises and examples of documents and other evidence, which reveals the effectiveness of the EMS.
- Understanding the roles of national, international bodies, certifiers and auditors in the certification of EMS.

**Note:** The course methodology includes a series of formal presentations, case studies, syndicate group exercises and extensive role play activities on real life situations.

## 5. RECOGNITION

The course is certificated with the IRCA -UK (International Register of Certificated Auditors) as an approved EMS Auditor/Lead Auditor Course (Course Registration No. A17479). The course meets the training requirements for individuals seeking registration as Auditors/Lead Auditor with IRCA.

## 6. COURSE MATERIAL

Registered participants are sent pre-course material in advance for preparation. Course kit comprising detailed course material and International Standard on EMS is given to each participant at the start of the training.

## 7. CERTIFICATE

Those participants who successfully complete the continuous assessment during the course and also the written examination, which is conducted on 5<sup>th</sup> day of the course, **will be issued certificate by Nigel Bauer & Associates, UK.**

## 8. COURSE ORGANISATION, SCHEDULE & REGISTRATION PROCEDURE

The course is of 5 days duration and starts at 0900 hrs and goes up to 1830 hrs daily for the first four days & on the fifth day the course finishes at 1700 hrs after the written examination. Tea/Coffee and working lunch is provided by the organizers.
