FEDERATION OF INDIAN CHAMBERS OF COMMERCE AND INDUSTRY

ELIGIBILITY FOR ORDINARY MEMBERSHIP (MEMBER-BODIES)

- A. Any Chamber of Commerce or Commercial or Trade or Industrial Association desirous of becoming an Ordinary Member of the Federation must fulfill at the following conditions viz. that:
- It has on its rolls not less than 40 members and a gross annual income of not less than Rs.7000/-; or
 - Not less than 10 members and a gross annual income of not less than Rs. 1 lakh.
 - Every Chamber of Commerce or Commercial or Trade or Industrial Association applying for the Ordinary Membership of the Federation shall be a functioning body for at least **two years** period to its so applying.
- B. Any application for admission as Ordinary Member of the Federation shall be sponsored by two Ordinary Members who are members of the Federation for a continuous period of not less than 5 years and a member of the Executive Committee or a Past President. The Sponsoring Ordinary Members shall belong to the same zone as that of the applicant sponsored by them. No Ordinary Member or a Member of the Executive Committee or a Past President shall sponsor more than 2 Ordinary members in a financial year.

ANNUAL SUBSCRIPTION

4 (a) The subscription payable by an Ordinary Member shall be for the Accounting year ending 30th June and shall be on the basis of the gross annual income (i.e. total of all receipts) of the Ordinary Member calculated in the following manner:

For gross annual income (i.e. total of all receipts) over Rs. 10 lakhs	15,000
